The Health Endowment Funds are utilized to further the impact of the Paso del Norte Health Foundation as it promotes health and prevents disease in the region through leadership in health education, research, and advocacy. The Foundation also facilitates giving and grant-making by working with agencies and/or charitable programs through a variety of Agency and Donor-Advised Funds.

4b (Code:) (Expenses \$ 396,843. including grants of \$ 356,187.) (Revenue \$)

El Paso Giving Day is a 24-hour online fundraising campaign built for nonprofits and fueled by a consortium of corporations, foundations, government officials, media partners and volunteers. Beyond the dollars raised, El Paso Giving Day provides a special high-profile day annually to bring attention to the work and worth of El Paso's nonprofit sector, help nonprofits increase their capacity, and introduce new and younger donors to charitable giving.

4c (Code:) (Expenses \$ including grants of \$) (Revenue \$)

The Playa Drain Trail is located in the Central-Lower Valley area of El Paso from Ascarate Park to Capistrano Park. The completed trail will include amenities such as trail paving, landscaping, interpretive signage, wayfinding, shade structures, benches, picnic tables and public art. The trail is designed to provide a safe corridor for the neighboring communities to link schools, commerce, housing, entertainment and transit and to encourage physical activity and outdoor recreation. During 2018, PdNCF made capital expenditures of \$2,159,026 towards the completion of the project. The project was accepted by and transferred to the City of El Paso during May 2019.

**Article VI
Limitation of Liability and Indemnification**

6.1 Limitation of Director Liability. The liability of a director to the Community Foundation for monetary damages for breach of fiduciary duty as a director shall be eliminated or limited to the fullest extent permitted by applicable law. Without limiting the effect of the preceding sentence, if applicable law is hereafter amended to authorize the further elimination or limitation of the liability of a director, then the liability of the director shall be eliminated or limited to the fullest extent permitted by applicable law, as so amended.

6.2 Indemnification. The Community Foundation shall have the power to indemnify to the fullest extent permitted by law and the bylaws of the Community Foundation (“**Bylaws**”), any person made or threatened to be made a party to an action or proceeding, whether criminal, civil, administrative or investigative, by reason or fact that such person is or was a director, officer, employee, or agent of the Community Foundation or any predecessor of the Community Foundation, or serves or served at any other enterprise as a director, officer, employee or agent at the request of the Community Foundation or any predecessor to the Community Foundation.

6.3 Change in Rights. Neither any amendment nor repeal of this Article VI, nor the adoption of any provision of this Certificate inconsistent with this Article VI, shall eliminate, reduce or otherwise adversely affect any limitation on the personal liability of a director existing at the time of such amendment, repeal or adoption of such an inconsistent provision.

Article VII Prohibitions and Restrictions

7.1 Inurement Prohibited. No part of the net earnings of the Community Foundation shall inure to the benefit of any private shareholder or individual, except that the Community Foundation may pay reasonable compensation for services rendered and may make payments in furtherance of the purposes set forth in Article II.

7.2 Restriction on Political Involvement. No substantial part of the activities of the Community Foundation shall be the carrying on of propaganda or otherwise attempting to influence legislation. The Community Foundation shall not participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of or in opposition to any candidate for public office.

7.3 Loans Prohibited. The Community Foundation shall not make loans to any director.

Article VIII Winding Up

Upon winding up of the Community Foundation, the Board, after complying with the requirements of the Business Organizations Code, shall apply and distribute all remaining property of the Community Foundation to the PdN Foundation exclusively for the purposes of the Community Foundation.

Article IX Miscellaneous

9.1 Private Foundation Provisions. Notwithstanding any other provision of this Certificate, if the Community Foundation is a private foundation, as that term is defined in Code section 509, the Community Foundation shall: (a) not engage in any act of self-dealing that would be subject to tax under Code section 4941; (b) make distributions at such time and in such manner as not to subject it to tax under Code section 4942; (c) not

retain any excess business holdings that would subject it to tax under Code section 4943; (d) not make any investments that would subject it to tax under Code section 4944; and (e) not make any taxable expenditures that would subject it to tax under Code section 4945.

9.2 Action By Less Than Unanimous Written Consent. The Bylaws may authorize the directors of the Community Foundation to take action without holding a meeting, providing notice, or taking a vote if such directors having at least the minimum number of votes that would be necessary to take the action that is the subject of the consent at a meeting, in which each such director entitled to vote on the action is present and votes, sign a written consent or consents stating the action taken.

9.3 Amendment of Certificate. Except as otherwise expressly provided in this Certificate or the Bylaws, any amendment, alteration, change, or repeal of this Certificate requires the approval of at least 75% of the Board.


9.4 Effective Date. This Certificate becomes effective when it is filed by the secretary of state.

Article X Statement of Approval

Each new amendment has been made in accordance with the provisions of the Business Organizations Code. The amendments have been approved in the manner required by the Business Organizations Code and the Bylaws.

The undersigned affirms that the person designated as the registered agent has consented to her appointment as such. The undersigned signs this Certificate subject to the penalties imposed by law for the submission of a materially false or fraudulent instrument and certifies under penalty of perjury that the undersigned is authorized to execute this Certificate.
